

## Privacy policy pursuant to Art.13 EU Reg. 679/2016

Thank you for taking a few minutes to check out this section of our website. Your privacy is very important to SINV SPA and to protect it we provide you with this note, in which you will find information on the type of informations collected online and the various possibilities you have to manage the collection and use of such informations on the site.

These informations are provided on the basis of art. 13 of Reg. 679/2016 - European General Data Protection Regulation, abbreviated GDPR - with regard to the processing of personal data of users who consult and interact with the SINV SPA website - www.sinv.com - (alias "the writer") and its services (e.g. site navigation information pages, requests for information by mail or other addresses provided, filling in forms, requests for access to restricted areas, etc.).

The policy is provided only for the site itself and not for other external sites that may be accessed by the user through links. Unless otherwise indicated, they will be referred to as the "site".

The information is also inspired by the European General Data Processing Regulation Reg. 679/2016, as well as the Recommendations of the European Union pursuant to Directive 2009/136/EC (e-privacy) on the processing of personal data and the protection of privacy, and to the provision of the Guarantor for the protection of personal data for the identification of simplified methods for the information and the acquisition of consent to the use of cookies (8 May 2014 - Published in the Official Gazette n. 126 of 3 June 2014) and guidelines on cookies and other tracking tools (June 2021).

## THE "DATA CONTROLLER" OF THE PROCESSING

### WHERE DATA ARE PROCESSED

The processing related to the web services of this site takes place at the office of the undersigned. The data are processed on the basis of their storage in computer archives, with the guarantee of compliance with appropriate measures in accordance with Articles 24 and 32 of the GDPR. No data deriving from the web service is communicated (except as specified below) or disseminated. Personal data provided by users who submit requests for information material (e.g. requests for information, newsletter subscriptions, etc.) are used for the sole purpose of performing the requested service or the request and are communicated to third parties only if this is necessary for this purpose (e.g. for shipping services).

## TYPES OF DATA PROCESSED

## Navigation data

The computer systems and software procedures responsible for the operation of this website acquire, during their normal operation, some personal data (e.g. log files) whose transmission is implicit in the use of Internet communication protocols.

We refer to informations that are not collected to be associated with identified subjects, but that by their very nature could, through processing and association with data held by third parties, allow to identify users. This category of data includes the IP addresses or domain names of the computers used by users connecting to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (good end, error, etc.) and other parameters related to the operating system and the computer environment of the user.

These data are used only to obtain anonymous statistical information on the use of the site and to check its correct functioning. The data may be used for the assessment of liability in case of hypothetical computer crimes against the site and may be presented to the Judicial Authority, if the latter explicitly requests it.

#### Data provided voluntarily by the user

The optional, explicit and voluntary sending of e-mail to the addresses indicated on this site or the compilation of any forms on the site involves the subsequent acquisition of the sender's address, necessary to respond to requests, and any other personal data entered in the letter. If informations are collected through the forms, you will be asked for specific consents and obligations to read the informations that refer to this page, in accordance with the "opt-in" or "privacy by default" principles of GDPR.

In addition, any summary information will be progressively reported or displayed in the pages of the site prepared for particular services on request.

For completeness it should be remembered that in some cases (not subject to the ordinary management of this site) the Authority may request news and information in order to control the processing of personal data. In these cases the response is mandatory, under penalty of administrative sanction.

# COOKIES

Cookies are a small amount of data that is stored in the RAM of your computer or on your hard drive whenever a website is visited.

We would like to inform you that this site may use only and exclusively cookies strictly necessary for the operation of the same. In particular, we may use session cookies (not persistent) strictly limited to what is necessary for safe and efficient navigation on the site.

# **OPTIONAL/NECESSARY PROVISION OF DATA**

Apart from what is specified for navigation data, the user is free to provide the personal data specified in the request forms to the undersigned or otherwise indicated in the contacts, to request the sending of information material or other communications. Failure to provide or incorrect provision may make it impossible to obtain what is required. To submit the forms you must read the privacy policy provided herewith.

## METHODS OF PROCESSING

Personal data are processed with automated tools for the time strictly necessary to achieve the purposes for which they were collected. Specific security measures are observed to prevent data loss, unlawful or incorrect use and unauthorized access.

## **RIGHTS OF DATA SUBJECTS**

The subjects to whom the personal data refer have the right at any time to obtain from the data controller, by contacting the addresses indicated in this document, the confirmation of the existence or not of the same data and to know the content and origin, verify its accuracy or request its integration or update, or the rectification (art. 15 to 21 GDPR). In accordance with this article, you have the right to request the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, as well as to object in any case, for legitimate reasons, to their processing.
